Scope of work:

To provide MAA with quotes pertaining to removal of old rollup door and installation of new rollup door. Vendor shall supply all necessary equipment and labor to remove and dispose of the existing rollup door and install a new rollup door including all necessary door tracks, hardware and any other items to produce a fully functional system. New door must meet any applicable Mobile City code requirements.

Technical:

Door Type – Commercial Wind loaded Sheet Door; door must have low profile drum box as there is a sprinkler pipe adjacent. (Contractor is responsible for verifying type)

Door size – Approximately 9.5 Ft x 12 Ft (Contractor is responsible for verifying measurements)
